ASSIGNOR represents that at the time of execution of this Trademark Assignment, ASSIGNOR has not otherwise assigned, transferred, licensed or encumbered ASSIGNOR'S rights therein, and that ASSIGNOR will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with this Trademark Assignment.

ASSIGNOR agrees to execute such further documents and take such acts as reasonably required by ASSIGNEE or ASSIGNEE'S successor to secure and enforce ASSIGNEE'S rights in the MARKS in the TERRITORY, including but not limited to further assignments.

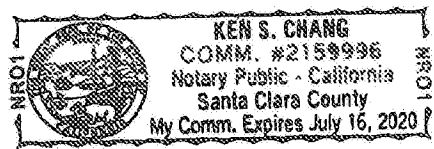

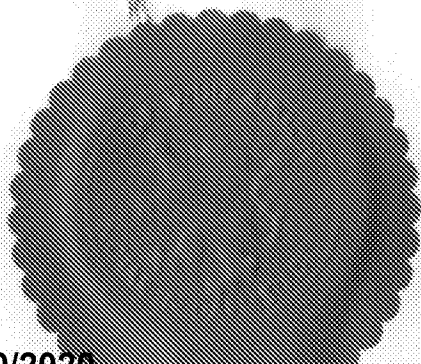
