Under Section 905 of the Business Corporation Law of the State of New York

Pursuant to Section 905 of the Business Corporation Law of the State of New York (the "NYBCL"), the undersigned does hereby certify this 14th day of April, 2017 that:

FIRST. The name and place of organization of each constituent entity is as follows:

(a) Hackster, Inc., a Delaware corporation ("Hackster"), which is a wholly owned subsidiary of Avnet, Inc.

(b) Avnet, Inc., a New York corporation ("Avnet").

The name of the surviving corporation is Avnet, Inc., a New York corporation (the "Surviving Corporation"), which was originally incorporated under the name of "Avnet Electronic Supply Co., Inc."

SECOND.

(a) Hackster has an authorized capitalization of 2,000,000 shares of capital stock, of which all are designated as common stock, of which 1,000,000 are issued and outstanding. Each share of common stock is entitled to one vote. All of such shares of common stock are owned by Avnet.

THIRD.

(a) The Agreement and Plan of Merger providing for the merger of Hackster into Avnet (the "Merger") was approved by the Board of Directors of Avnet on August 11, 2016.

FOURTH.

(a) The Certificate of Incorporation of Hackster was filed with the Secretary of State of the State of Delaware on October 9, 2013 and no application has been filed for authority to do business in the State of New York.

(b) The Certificate of Incorporation of Avnet, Inc. was filed on July 22, 1955.

(c) The Certificate of Incorporation of Avnet, Inc. will be the Certificate of Incorporation of the Surviving Corporation.

(d) The merger is permitted by the laws of the state of incorporation of the foreign subsidiary and is in compliance therewith.
