ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL

ASSIGNMENT dated as of January 28, 2020, from PineBridge Structured Capital Partners III, L.P. (“PB Structured Capital”) and PineBridge Structured Capital Partners Offshore III-A, L.P. (together with PB Structured Capital, the “Existing Purchasers”), to Lucky Golden Toy Finance I, LLC (“Golden I”) and Lucky Golden Toy Finance II, LLC (together with Golden I, the “Successor Purchasers”). All terms capitalized but not otherwise defined herein shall have the meanings as in the Trademark Security Agreement as defined below.

W I T N E S S E T H:

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of July 27, 2018 by Poof-Slinky, LLC in favor of the Existing Purchasers, recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on November 13, 2018 at Reel 6536 Frame 0352 (the “Trademark Security Agreement”), Poof-Slinky, LLC granted a security interest to the Existing Purchasers for the ratable benefit of the holders of the Secured Obligations in certain Trademark Collateral including the trademarks set forth on Schedules A hereto;

WHEREAS, the Existing Purchasers has assigned all of their rights, powers and privileges under the Trademark Security Agreement to the Successor Purchasers; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Assignment, the Existing Purchasers hereby acknowledges and agrees as follows:

1. Definitions. The term “Trademark Collateral” shall mean those items listed on Schedule 1 of the Trademark Security Agreement, and includes, without limitation, those items listed on Schedule A.

2. Assignment of Security Interest. The Existing Purchasers hereby assign all of its rights, powers and privileges under the Trademark Security Agreement, including those respecting the Trademark Collateral, to the Successor Purchasers.

3. Further Assurances. The Existing Purchasers hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect this Assignment.
