- B. Perrigo has agreed to assign the Trademark to Amazon, for good and valuable consideration and in accordance with the following terms.




- 1. Authority. The undersigned signatories represent and warrant that they have the full authority to enter into this Agreement on behalf of the Party for which they sign.
