**RELEASE OF GRANT OF SECURITY INTEREST  
IN CERTAIN INTELLECTUAL PROPERTY**

This Release of Grant of Security Interest in Certain Intellectual Property (this "Release") is made and entered into this 13th day of February, 2004, by and between Agway, Inc., a Delaware corporation, and General Electric Capital Corporation, a Delaware corporation.

**W I T N E S S E T H :**

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of March 28, 2001 recorded at the United States Patent and Trademark Office at (i) Reel 011667 and Frame 0479 on April 4, 2001 and (ii) Reel 002317 and Frame 0388 on April 5, 2001 (the "Security Agreement"), made by Agway, Inc., ("Agway"), Agway Holdings Inc., ("AHI"), Agway Financial Corporation ("AFC"), Feed Commodities International LLC, ("FCI"), Milford Fertilizer Company LLC, ("MFC"), Brubaker Agronomic Consulting Service LLC ("BACS"), Agway General Agency, Inc. ("AGA"), Country Best Adams, LLC ("CBA"), Country Best-Deberry LLC, ("CBD"), Agway Energy Products LLC, ("AEP"), Agway Energy Services-PA, Inc., ("AESPA"), and Agway Energy Services, Inc., ("AES"); (Agway, AHI, AFC, FCI, MFC, BACS, AGA, CBA, CBD, AEP, AESPA and AES are, together, the "Prepetition Borrowers") in favor of GENERAL ELECTRIC CAPITAL CORPORATION ("GECC"), in its capacity as agent for Lenders pursuant to which, inter alia, the Prepetition Borrowers granted to GECC a security interest in the Prepetition Borrowers' right, title, and interest into the intellectual property registrations and applications listed on Schedule A hereto (the "Intellectual Property"); and

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of October 4, 2002 recorded at the United States Patent and Trademark Office at (i) Reel 013386 and Frame 0207 on October 15, 2002 and (ii) Reel 002596 and Frame 0001 on October 15, 2002 (the "DIP Security Agreement"), made by Agway, Inc., Feed Commodities International LLC, Brubaker Agronomic Consulting Service LLC, Agway General Agency, Inc., Country Best Adams, LLC, Country Best-Deberry LLC, (collectively, the "Debtor DIP Borrowers"), Agway Energy Products LLC, Agway Energy Services-PA, Inc., and Agway Energy Services, Inc., (collectively, the "Non-Debtor DIP Borrowers") together with the Debtor DIP Borrowers, the "DIP Borrowers") in favor of GECC, in its capacity as agent for Lenders pursuant to which, inter alia, the DIP Borrowers granted to GECC a security interest in the DIP Borrowers' right, title, and interest into the intellectual property registrations and applications listed on Schedule A hereto (the "DIP Intellectual Property"); and

WHEREAS, the Prepetition Borrowers and the DIP Borrowers are hereafter collectively referred to as the "Borrowers."

WHEREAS, the Borrowers have requested that GECC release all of GECC's security interests in the Intellectual Property and DIP Intellectual Property, and GECC, in its capacity as Agent, under the Security Agreement and the DIP Security Agreement (the "Agent"), has agreed to do so.

NOW THEREFORE, in consideration of the foregoing, the parties to this Release intending to be legally bound, agree as follows.

6. This Release may be executed in any number of separate counterparts, each of which, when so executed, shall be deemed an original, and all of said counterparts taken together shall be deemed to constitute but one and the same instrument.


