WHEREAS, Lender desires to terminate and release its security interest in the Intellectual Property; and


NOW, THEREFORE, Lender by these presents does hereby release its security interest in the Intellectual Property as set forth in the Agreement.

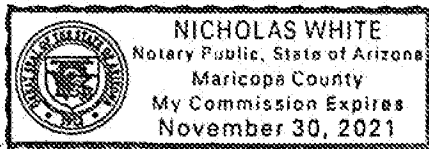
