**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (“Trademark Release”) is made as of April 1, 2020, by **CITIZENS BANK, N.A.**, a United States national banking association (the “Collateral Agent”) in favor of the **MAG DS CORP.**, a Delaware corporation with an address at 12730 Fair Lakes Circle, Suite 600, Fairfax, Virginia 22033, **AVENGE CORPORATION**, a Delaware corporation with an address at 12730 Fair Lakes Circle, Suite 600, Fairfax, Virginia 22033, and **UAV COMMUNICATIONS, INC.**, a Virginia corporation with an address at One Bayport Way, Suite 250, Newport News, Virginia 23606 (each, a “Grantor”, and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated June 6, 2016 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded with the United States Patent and Trademark Office on June 6, 2016 at Reel 6347, Frame 0890.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in all of each such Grantor’s right, title and interest in or to the Trademark Collateral, including without limitation the trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors the Security Interest in such Trademark Collateral. The Lender further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantors and its successors and assigns in association with the Security Interest, and hereby releases the Grantors and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
