TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST ("Termination and Release") dated as of May 1, 2020, is made from CITIZENS BANK, N.A., f/k/a RBS Citizens, National Association (the "Secured Party") to ENEFCO INTERNATIONAL, INC., a Delaware corporation, having a place of business at 1130 Minot Avenue, Auburn, Maine 04211 (the "Debtor"). WHEREAS, the Secured Party now desires to terminate and release its security interest in the Marks and reassign any and all rights, title, and interest in the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Debtor's right, title and interest in and to the Marks, including those trademarks set forth on Schedule A.

2. If and to the extent that Secured Party has acquired any right, title or interest in or to any of the Marks, Secured Party hereby reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, any and all of Secured Party's right, title, and interest in and to the Marks, along with any goodwill in the trademarks that the Secured Party may have acquired.
