**CONTRIBUTION AGREEMENT**

THIS CONTRIBUTION AGREEMENT (this “Agreement”) is made and entered into as of September 1, 2019, by and between KSF Acquisition Corporation, a Delaware corporation (“Parent”), and GPN SlimFast Commercial, LLC, a Delaware limited liability company (“Subsidiary”).

**WHEREAS**, in connection with a reorganization of Parent and its affiliates, Parent desires to contribute all of its right, title and interest in and to any and all of the following in the United States and Canada and, to the extent applicable, any jurisdiction throughout the world: (a) trade names, trademarks, service marks, brand names, taglines, slogans and trade dress, including all foreign and domestic applications and registrations (including product registrations) and the goodwill connected with the use of and symbolized by the foregoing, inclusive of those which are set forth on **Schedule A** attached hereto; (b) copyrights in both published works and unpublished works, including all applications and registrations related to the foregoing; (c) trade secrets, inventions and discoveries that may or may not be patentable, product formulations, proprietary information, supplier, co-manufacturing and co-packing lists and information, technical information and process technology, know-how, manufacturing processes, confidential know-how, software, product recipes, consumer data, business plans and blueprints, or any other related information; (d) patents, patent applications, industrial designs, including, without limitation, all foreign, domestic, regional and international applications and registrations of the foregoing, inclusive of those which are set forth on **Schedule B** attached hereto; (e) websites, internet domain name registrations and social media handles, inclusive of those which are set forth on **Schedule C** attached hereto; (f) any rights to use any characteristics, name, history or story of any third-person, including any such natural person’s name, signature, likeness, image, quotes, testimonials, sayings or life story and (g) all other intellectual property and related proprietary rights, interests and protections (including all rights to sue and recover and retain damages, costs and attorneys’ fees for past, present and future infringement and any other rights relating to any of the foregoing), to Subsidiary (such distributed assets, the “Contributed Assets”); and

**WHEREAS**, in connection with said reorganization of Parent and its affiliates, Parent desires for Subsidiary to assume all liabilities and obligations of Parent, whether matured or unmatured, accrued, contingent or otherwise, arising out of or relating to the Contributed Assets (the “Assumed Liabilities”), other than any such liability or obligation which has arisen out of or relates to assets other than the Contributed Assets (the “Excluded Liabilities”).

**NOW, THEREFORE**, Parent and Subsidiary, intending to be legally bound, agree as follows:

1. Contribution of Assets. As of 12:01 a.m. local time on the date hereof, Parent hereby contributes to Subsidiary, and Subsidiary hereby accepts from Parent, all of Parent’s right, title and interest in and to all of the Contributed Assets, subject to such liens, encumbrances and restrictions as any such Contributed Asset may be subject to at such time. Parent does not assign, transfer or convey to Subsidiary any asset other than the Contributed Assets.
2. Assumption of Liabilities. As of 12:01 a.m. on the date hereof, Subsidiary hereby assumes all responsibility and liability (if any) for, and agrees (as between Parent and Subsidiary)

to pay and perform any obligations related to, all of the Assumed Liabilities. Subsidiary does not assume, undertake, accept or agree to be bound by any Excluded Liability.

3. Additional Documents. Parent and Subsidiary further agree to execute any and all additional documents necessary to effectuate the foregoing contribution of assets and liabilities, including such documents which assign, transfer, convey and deliver to Subsidiary all of the Contributed Assets and cause Subsidiary to assume and become responsible for all of the Assumed Liabilities.

4. Disclaimer of Warranties. PARENT AND SUBSIDIARY HEREBY ACKNOWLEDGE AND AGREE THAT THE CONTRIBUTED ASSETS ARE BEING CONVEYED "AS-IS," "WHERE-IS" AND "WITH ALL FAULTS," EXCEPT TO THE EXTENT THAT THE CONTRIBUTED ASSETS INCLUDE ANY THIRD-PARTY WARRANTY IN FAVOR OF PARENT, ALL OF WHICH CONSTITUTE CONTRIBUTED ASSETS AND ARE CONVEYED HEREBY. PARENT HEREBY DISCLAIMS AND EXCLUDES ALL WARRANTIES, INCLUDING THOSE OF QUALITY, FITNESS AND MERCHANTABILITY, WHETHER EXPRESS OR IMPLIED, OR ARISING AS A MATTER OF LAW AND PARENT MAKES NO WARRANTIES OF ANY KIND OR NATURE, EXPRESS OR IMPLIED, NOR DOES PARENT MAKE ANY REPRESENTATIONS OR STATEMENTS AS TO ANY FACTS, CIRCUMSTANCES, CONDITIONS OR MATTERS OF ANY KIND WHATSOEVER, INCLUDING BUT EXPRESSLY NOT LIMITED TO THE CONDITION OF THE CONTRIBUTED ASSETS, AND/OR THEIR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

5. Further Assurances. Each of the parties hereto shall execute and deliver, at the reasonable request of the other party hereto, such additional documents, instruments, conveyances and assurances and take such further actions as such other party may reasonably request to carry out the provisions hereof and give effect to the transactions contemplated by this Agreement.

6. Entire Agreement. This Agreement constitutes the sole and entire agreement of the parties hereto with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.

7. No Third Party Beneficiaries. Nothing in this Agreement, express or implied, is intended to confer any right or remedy under or by reason of this Agreement on any person other than the parties hereto and their respective representatives, successors and assigns, nor is anything set forth herein intended to affect or discharge the obligation or liability of any third parties to any party hereto, nor shall any provision of this Agreement give any third party any right of subrogation or action over or against any party hereto.




