INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “IP Security Agreement”) dated May 19, 2020, is made each of by the Persons listed on the signature pages hereof (each, a “Grantor” and, collectively, the “Grantors”) in favor of THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A. (“BNYM”), in its capacity as security agent under the Indenture referred to below (in such capacity, together with its successors in such capacity, the “Security Agent”).

WHEREAS, ROYAL CARIBBEAN CRUISES LTD. (the “Issuer”), a Liberian corporation, the guarantors party thereto from time to time and BNYM, as Trustee and as Security Agent entered into an Indenture, dated as of May 19, 2020 (as amended, supplemented and/or otherwise modified from time to time, the “Indenture”). Capitalized terms used herein, defined in the Indenture and not otherwise defined herein are used herein as defined in the Indenture.

WHEREAS, each Grantor has executed and delivered that certain Pledge and Security Agreement, dated May 19, 2020, made by the Grantors to the Security Agent (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Pledge and Security Agreement”).

WHEREAS, under the terms of the Pledge and Security Agreement, the Grantors have granted to the Security Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby pledges, assigns and grants to the Security Agent, on behalf of and for the ratable benefit of the Secured Parties, and to secure the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of all Secured Obligations (but subject to all limitations set forth in the Pledge and Security Agreement or in the Indenture, including the Collateral Cap), a continuing lien on and security interest in all of its right, title and interest in, to and under all of the following property, owned by or owing to, or in which such Grantor has any right, title or interest, and regardless of where located (all of which are collectively referred to as the “Collateral”), to the extent owned by a Grantor:

(i) all trademarks, service marks, trade dress, logos, designs, slogans, trade names, and other source identifiers, whether registered or unregistered (provided that no security interest shall be granted in (and the definition of Collateral shall not include) United States Trademark applications filed on the basis of the applicant’s intent-to-use such Trademark, to the extent that, and solely during the period in which, the grant of a security interest therein would impair or adversely affect the validity or enforceability of such intent-to-use Trademark application under applicable federal law; provided that upon submission to and acceptance by the U.S. Patent and Trademark Office of evidence of use of the Trademark pursuant to Section 1(c) or Section 1(d) of the Lanham Act (15 U.S.C. §1051, et seq.) (or any successor provision), such intent-to-use Trademark application shall be included in the Collateral and have the security interest granted against it), together, in each case, with the goodwill symbolized thereby (collectively, “Trademarks”), including those registrations and applications listed on Schedule I hereto;

(ii) all registrations and applications for registration for any of the foregoing;

(iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages;

(iv) any and all income, royalties and other payments now or hereafter due and payable with respect to any and all of the foregoing or arising from any of the foregoing; and

(v) all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; and

(vi) any and all proceeds of any of the foregoing.

SECTION 2. Security for Secured Obligations. The grant of a security interest in the Collateral by each Grantor under this IP Security Agreement secures the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of all the Secured Obligations of such Grantor (but subject to all limitations set forth in the Pledge and Security Agreement or in the Indenture, including the Collateral Cap). Without limiting the generality of the foregoing, this IP Security Agreement secures, as to each Grantor, the payment of all amounts that constitute part of the Secured Obligations and that would be owed by such Grantor to the Security Agent or the Secured Parties under the Indenture Documents but for the fact that such Secured Obligations are unenforceable or not allowable due to the existence of an Insolvency or Liquidation Proceeding involving a Grantor.

SECTION 3. Recordation. Each Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this IP Security Agreement.

SECTION 4. Execution in Counterparts. The parties may sign any number of copies of this IP Security Agreement. Each signed copy will be an original, but all of them together represent the same agreement. The exchange of copies of this IP Security Agreement and of signature pages by facsimile or electronic format (i.e., "pdf" or "tif" or any electronic signature complying with the U.S. federal ESIGN Act of 2000) transmission shall constitute effective execution and delivery of this IP Security Agreement as to the parties hereto and may be used in lieu of the original IP Security Agreement for all purposes. Signatures of the parties hereto transmitted by facsimile or electronic format (i.e., "pdf" or "tif" or any electronic signature complying with the U.S. federal ESIGN Act of 2000) shall be deemed to be their original signatures for all purposes. Any electronically signed document delivered via email from a person purporting to be an authorized officer shall be considered signed or executed by such authorized officer on behalf of the applicable Person. The Security Agent shall have no duty to inquire into or investigate the authenticity or authorization of any such electronic signature and shall be entitled to conclusively rely on any such electronic signature without any liability with respect thereto


SECTION 5. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Pledge and Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights, protections, immunities, reliances and remedies of, the Security Agent with respect to the Collateral are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

SECTION 6. Governing Law. This IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York, without reference to any conflicts of law provisions which would require the application of the laws of any other State or jurisdiction.

SECTION 7. Limitation on Secured Obligations. Notwithstanding anything to the contrary contained herein or in any other Indenture Document, the security interest created pursuant to this IP Security Agreement or any other Security Document shall be subject in all respects to, and the Secured Obligations shall in no case exceed, the Collateral Cap and the other limitations set forth herein or in any other Indenture Document.
