## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (as supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) dated May 29, 2020, is made by UNITED STATES STEEL CORPORATION, a Delaware corporation (the “Company”), the Subsidiaries of the Company from time to time a party hereto (each a “Subsidiary Grantor” and collectively, the “Subsidiary Grantors”, and together with the Company, the “Grantors”, and each, a “Grantor”) in favor of U.S. Bank National Association, as Collateral Agent (in such capacity the “Collateral Agent”) for the Notes Secured Parties.

### W I T N E S S E T H:

WHEREAS, the Grantors have entered into that certain Indenture, dated as of May 29, 2020 (as supplemented or otherwise modified from time to time, the “Indenture”), by and among the Grantors and the Collateral Agent, as trustee (in such capacity the “Trustee”);

WHEREAS, in connection with Indenture, each Grantor has executed and delivered that certain Collateral Agreement, dated as of the date hereof, made by the Grantors to the Collateral Agent (as supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, under the terms of the Collateral Agreement, the Grantors have granted to the Collateral Agent, for the ratable benefit of the Notes Secured Parties, a security interest in, among other property, certain Trademarks of the Grantors, and have agreed as a condition thereof to execute this Trademark Security Agreement for recording with the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Trademark Security Agreement, including in its preamble and recitals, have the meanings provided or provided by reference in the Collateral Agreement.

SECTION 2. Grant of Security. Each Grantor hereby assigns and transfers to the Collateral Agent, and hereby grants to the Collateral Agent, for the ratable benefit of the Notes Secured Parties, a security interest in all of such Grantor’s right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on Schedule A hereto, collectively the “Collateral”).

SECTION 3. Security for Obligations. The grant of a security interest in the Collateral by each Grantor under this Trademark Security Agreement secures the payment of all Notes Obligations of such Grantor now or hereafter existing under or in respect of the Indenture and the Notes (including any increases of the principal amount outstanding thereunder).

SECTION 4. Recordation. Each Grantor authorizes and requests the Commissioner for Trademarks and any other applicable government officer record this Trademark Security Agreement.

SECTION 5. Grants, Rights and Remedies. This Trademark Security Agreement has been entered into in conjunction with the provisions of the Collateral Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.


SECTION 6. Counterparts. This Trademark Security Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. The words "execution," "signed," "signature," "delivery," and words of like import in or relating to this Trademark Security Agreement or any document to be signed in connection with this Trademark Security Agreement shall be deemed to include electronic signatures, deliveries or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system, as the case may be, and the parties hereto consent to conduct the transactions contemplated hereunder by electronic means.

SECTION 7. Governing Law. This Trademark Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
