**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

Release of Security Interest in Trademarks, dated as of June 1, 2020 by HPS INVESTMENT PARTNERS, LLC, as collateral agent (“Releasor”) to APTIV DIGITAL LLC, GEMSTAR DEVELOPMENT LLC, ROVI CORPORATION, ROVI DATA SOLUTIONS, INC., ROVI GUIDES, INC., ROVI SOLUTIONS CORPORATION, ROVI TECHNOLOGIES CORPORATION, SONIC SOLUTIONS LLC, TIVO BRANDS LLC, TIVO RESEARCH AND ANALYTICS, INC., and TIVO SOLUTIONS INC. (each individually, a “Releasee” and, collectively the “Releasees”).

**WITNESSETH:**

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 22, 2019 (the “Trademark Security Agreement”), recorded in the United States Patent and Trademark Office (“USPTO”) on November 22 2019 under Reel/Frame 6802/0417, by Releasees to Releasors, each Releasee, as collateral security for the payment and performance in full of all the Secured Obligations, pledged and granted to Releasor for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under (a) all the Trademarks of such Releasee listed on Schedule A hereto; (b) all goodwill associated with such Trademarks; (c) Trademark Licenses, pursuant to which a third party is granting rights to any Releasee, included in the Material Intellectual Property Collateral listed on Schedule A attached hereto; and (d) all Proceeds of any and all of the foregoing (other than Excluded Property) (collectively, the “Trademark Collateral”); and

WHEREAS, each Releasee has requested, and Releasor has agreed to execute, acknowledge and deliver, this Release of Security Interest in Trademarks to terminate the Trademark Security Agreement and confirm the release, relinquishment and discharge of its continuing security interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, Releasor hereby agrees as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, capitalized terms used herein shall have the meaning given to them in the Trademark Security Agreement.

SECTION 2. Release of Security Interest. Releasor hereby, without any representation or warranty and without any recourse to Releasor, terminates the Trademark Security Agreement and hereby terminates, releases, relinquishes and discharges its lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral.

SECTION 3. Further Assurances. The Releasor further agrees to execute and deliver to each Releasee any and all further documents and instruments, and do any and all further acts which each Releasee (or its agents or designees) may reasonably request, at such Releasee’s sole cost and expense, in order to confirm this Release of Security Interest in Trademarks and such Releasee’s right, title, and interest in or to the Trademark Collateral.

SECTION 4. Governing Law. THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK.


