**THIS ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS** (this "Assignment") is made and entered into and effective as of March 13, 2020, by and between BMO Harris Bank N.A. ("Assignor"), and BMO Harris Bank N.A., as Administrative Agent ("Assignee").

**WITNESSETH**

**WHEREAS**, Assignor and AB Specialty Silicones, LLC ("Grantor") are parties to that certain Trademark Security Agreement, dated as of October 7, 2015 (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office on October 9, 2015 as document #900340445, pursuant to which Assignor has a continuing security interest in and lien on all or substantially all of the Grantor's Trademark Collateral including, without limitation, the registrations and applications thereof listed on Schedule I attached hereto;

**WHEREAS**, Assignor and Assignee are parties to that certain Omnibus Assignment Agreement, dated as of October 31, 2018 (the "Omnibus Assignment Agreement"), pursuant to which, among other things, Assignor assigned and transferred all its security interest and lien under the Trademark Security Agreement and all of its other rights and other benefits under the Trademark Security Agreement to Assignee; and

**WHEREAS**, by way of this Assignment, Assignee wishes to record in the United States Patent and Trademark Office evidence of the assignment transaction described in the Omnibus Assignment Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without limiting the generality or effectiveness of the Omnibus Assignment Agreement, Assignor hereby confirms its prior assignment and transfer to Assignee and assigns, transfers and sets over, without representations or warranties of any type whatsoever, and without recourse, to Assignee, Assignor's entire right, title and interest in and to the Trademark Security Agreement and to the secured rights in and to the Trademark Collateral, including, without limitation, the registrations and applications thereof listed on Schedule I attached hereto and to all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties, damages or payments due or payable as of the date hereof or hereafter.

Assignor hereby authorizes and requests the United States Patent and Trademark Office to record Assignee as owner of the Trademark Security Agreement and the secured rights in and to the Trademark Collateral, including, without limitation, the registrations and applications thereof listed on Schedule I attached hereto and to recognize the same.

This Assignment may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Assignment by facsimile

or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Assignment.


