Pursuant to Section 347.725 of the statutes of the State of Missouri (the "Missouri Merger Statute"), Federal-Mogul Products US LLC, a Missouri limited liability company ("Federal-Mogul"), does hereby certify that:

**FIRST:** The names of the constituent companies are the following: (i) the name of the surviving limited liability company (the "Surviving Company") is Federal-Mogul Products US LLC, a Missouri limited liability company, and (ii) the name of the corporation being merged into the Surviving Company is Federal-Mogul Products, Inc., a Missouri corporation (the "Company" and, together with Federal-Mogul, the "Constituent Companies").
