GRANT OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement"), effective as of August 6, 2020 is made by OLIN CORPORATION, a Virginia corporation, located at 190 Carondelet Plaza, Suite 1530, Clayton, Missouri 63105 (the "Obligor"), in favor of BANK OF AMERICA, N.A., as Administrative Agent (the "Agent") for the Secured Parties (the "Secured Parties"), referred to in the Credit Agreement, dated as of July 16, 2019 (as modified and supplemented and in effect from time to time, the "Credit Agreement"), among Olin Corporation, a Virginia corporation ("Company"), the lenders party thereto and the Agent.

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement and certain other agreements referred to therein, the Secured Parties have agreed to make loans and other extensions of credit and accommodations to the Company and its Subsidiaries upon the terms and subject to the conditions set forth therein; and

WHEREAS, in connection therewith, the Company and certain of its Subsidiaries have executed and delivered a Security Agreement, dated as of August 6, 2020, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Obligor pledged and granted to the Agent, for the benefit of the Agent and the Secured Parties, a continuing security interest in all Intellectual Property, including the Trademarks; and

WHEREAS, the Obligor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Secured Parties to make loans and other financial accommodations to the Company and its Subsidiaries pursuant to the Credit Agreement and the other agreements referred to therein, the Obligor agrees, for the benefit of the Agent and the Secured Parties, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and the Security Agreement.

SECTION 2. Grant of Security Interest. The Obligor hereby pledges and grants a continuing security interest in all of the Obligor's right, title and interest in, to and under the Trademarks, including those listed on Schedule A hereto (collectively, the "Collateral"), to the Agent for the benefit of the Agent and the Secured Parties to secure payment, performance and observance of the Obligations. Notwithstanding the foregoing, the Collateral does not and shall not include any Excluded Trademarks.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Obligor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Agent in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Agent thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Obligor does hereby further acknowledge and affirm that the rights and remedies of the Secured Parties with respect to the security interest in the Collateral granted hereby are more fully set forth in the Credit Agreement and the Security Agreement. In the event of any conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
