

INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "<u>Agreement</u>") made as of this 16th day of December 2019, by the Persons listed on the signature pages hereof (collectively, "<u>Grantors</u>"), in favor of PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders described herein ("<u>Agent</u>"). Capitalized terms used, but not defined, herein shall have the meanings ascribed thereto in that certain Revolving Credit, Term Loan and Security Agreement, dated as of the date hereof, with the financial institutions which are now or which thereafter become a party thereto (collectively, the "<u>Lenders</u>" and each individually a "<u>Lender</u>"), and Agent (as amended, modified, supplemented, renewed, restated or replaced from time to time, the "<u>Credit Agreement</u>").

WITNESSETH

WHEREAS, Grantors, Clover Parent, LLC, a Delaware limited liability company ("<u>Clover Parent</u>") and certain Subsidiaries of Clover Parent party thereto from time to time as Borrowers and/or Guarantors, the financial institutions party thereto as lenders from time to time (the "<u>Lenders</u>") and PNC Bank, National Association, as agent for the Lenders (in such capacity, "<u>Agent</u>"), have entered into the Credit Agreement, providing for certain extensions of credit to be made by Lenders to Borrowers:

WHEREAS, as security for the Obligations under the Credit Agreement, each Grantor has granted to Agent, for the benefit of the Secured Parties, a security interest in substantially all of the assets of such Grantor, including without limitation, all right, title and interest of such Grantor in, to and under all now owned and hereafter acquired all Intellectual Property (other than Excluded Assets), including the Intellectual Property Collateral (defined below);

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

- 1. <u>Incorporation of Credit Agreement</u>. The Credit Agreement and the terms and provisions thereof are hereby incorporated in their entirety by this reference. All terms capitalized but not otherwise defined herein shall have the same meanings given to such terms in the Credit Agreement.
- 2. <u>Grant and Reaffirmation of Grant of Security Interests</u>. To secure the prompt payment and performance to Agent, each Issuer, each Lender and each other Secured Party of the Obligations, each Grantor hereby assigns, pledges and grants to Agent, for the ratable benefit of the Secured Parties, a continuing security interest in and to and Lien on all rights, title and interest of such Grantor in all of the following property and assets of such Grantor (collectively, the "<u>Intellectual Property Collateral</u>"), in each case whether now existing or hereafter arising or created and whether now owned or hereafter acquired:
- (a) each trademark and trademark application listed on <u>Schedule 1</u> annexed hereto (such trademarks and trademark applications, the "<u>Trademarks</u>"), each copyright and copyright application listed on <u>Schedule 2</u> annexed hereto (such copyrights and copyright applications, the "<u>Copyrights</u>"), and each patent and patent application listed on <u>Schedule 3</u> annexed hereto (such patents and patent applications, the "<u>Patents</u>");
 - (b) any reissues, continuations or extensions of the foregoing;
- (c) all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(d) all products and proceeds of the foregoing in whatever form, including without limitation, any claim by any Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, Copyright or Patent, or (ii) injury to the goodwill associated with any Trademark.

Notwithstanding the foregoing, Intellectual Property Collateral shall not include any Excluded Assets (including any "intent-to-use" trademark applications).

3. Miscellaneous

- (a) <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Agreement by signing and delivering one or more counterparts. Delivery of this Agreement by facsimile or electronic transmission shall bind the parties hereto.
- (b) <u>Governing Law</u>. This Agreement and the transactions contemplated hereby, and all disputes between the parties under or relating to this Agreement or the facts or circumstances leading to its execution, whether in contract, tort or otherwise shall be governed by and construed in accordance with the laws of the State of New York.
- (c) <u>Termination</u>. This Agreement and the Liens granted hereunder shall automatically terminate upon the Payment in Full of the Obligations and the termination of the Commitments and the Credit Agreement pursuant to and in accordance with Article 13 of the Credit Agreement.
