**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of August 17, 2020 by **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 2400 Hanover Street, Palo Alto, California 94304, and **GOLD HILL CAPITAL 2008, LP**, a Delaware corporation, with a loan production office located at One Almaden Blvd., Suite 630, San Jose, California 95113 (collectively, the “*Secured Parties*”), in favor of **FORESCOUT TECHNOLOGIES, INC.**, located at 10001 N. De Anza Blvd., Suite 220, Cupertino, CA 95014 (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of October 24, 2012 (as amended, modified, restated, replaced, or supplemented from time to time prior to the date hereof, the “*Agreement*”; capitalized terms used herein are used as defined in the Agreement), granting to the Secured Parties a security interest in all of its right, title and interest in, to and under the Intellectual Property Collateral, whether then existing or thereafter acquired, including all of its right, title and interest in, to and under its Patents and Trademarks, notice of which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on October 25, 2012 at Reel 029210, Frame 0075, and at Reel 004893, Frame 0388.

WHEREAS, Grantor has requested that the Secured Parties hereby terminate, release and discharge fully their security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property Collateral (including without limitation those Patents and Trademarks listed on Schedule I hereto) as herein provided; and

WHEREAS, Grantor has requested that the Secured Parties provide a document suitable for recording with the USPTO to evidence the release of the Secured Parties’ security interests in and liens on the Intellectual Property Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Parties hereby:

1. terminate the Agreement and release, terminate and discharge fully all liens and security interests in Grantor’s right, title and interest in, to and under the Intellectual Property Collateral ; and
2. authorize and request that this Termination and Release be recorded with the USPTO.
