## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of August 21, 2020 (the "Release"), is made by ANTARES CAPITAL LP, in its capacity as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of VISION TECHNOLOGY SOLUTIONS, LLC, a Delaware limited liability company (the "Pledgor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement, or if not defined therein, in the Credit Agreement.

### WITNESSETH

WHEREAS, the Pledgor and the Collateral Agent are parties to that certain First Amended and Restated First Lien Credit Agreement, dated as of February 9, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and that certain First Amended and Restated First Lien Security Agreement, dated as of February 9, 2018 (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Pledgor executed the First Lien Trademark Security Agreement, dated as of February 9, 2018 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on February 9, 2018 at Reel/Frame No. 6270/0484, pursuant to which the Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

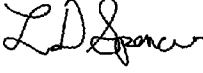
WHEREAS, the Pledgor has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
