TRADEMARK AND DOMAIN NAME ASSIGNMENT

This Trademark and Domain Name Assignment (the "**Assignment**"), dated as of 19 November 2019, is by and between Levlad, LLC, a Delaware limited liability company locate at 9400 Jeronimo Road, Irvine, CA 92618 ("**Assignor**"), and iHerb, LLC, a Delaware limited liability company located at 301 North Lake Avenue, Suite 600, Pasadena, California 91101 ("**Assignee**").

RECITALS:

Assignor is the owner of certain trademark applications and registrations as well as domain names listed on the attached Schedule A (the "**Assigned Rights**");

The Assignor and Assignee have entered into a Goodwill and Intellectual Property Purchase Agreement of dated September 12, 2019 ("**Purchase Agreement**") pursuant to which Assignor is selling certain assets to Assignee, including the Assigned Rights; and

Pursuant to the Purchase Agreement, the Assignee has acquired all right, title and interest in and to the Assigned Rights, and the parties wish to record such acquisition in the United States Patent and Trademark Office.

THEREFORE, in consideration of the sum of \$1.00 and other good and valuable consideration paid by the Assignee to the Assignor, the receipt and sufficiency of which is here acknowledged, Assignor and Assignee agree as follows:

1. **Assignment.** Effective as of this date, and pursuant to the Purchase Agreement, the Assignor has transferred their businesses to which the Assigned Rights relate to the Assignee and the Assignor sells, transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of the Assignor in and to: (i) the domain names, trademarks and trademark applications set forth in the attached Schedule A, together with the goodwill of the business symbolized by the Assignment; (ii) all renewals and extensions of any such application, registration and filing; (iii) all licenses for the use of the Assigned Rights; (iv) all income, royalties, damages, claims, and payments now or in the future due or payable under and with respect to the Assigned Rights, including, without limitation, damages, claims, and payments for past and future infringements of the Assigned Rights; (v) all rights to sue for past, present, and future infringements of the above, including the right to settle suits involving claims and demands for royalties owing; (vi) all rights corresponding to any of the above throughout the world; and (vii) the right to assign the rights conveyed here, the same to be held and enjoyed by Assignee for its own use and benefit, and for the benefit of its successors, assigns, and legal representatives.

2. **Governing Law.** This Assignment will be governed by, and construed in accordance with (i) the laws of the United States, in respect to domain name and trademarks issues, and (ii) in all other respects, including as to validity (except for trademarks issues), interpretation and effect, by the laws of the state of California without giving effect to the conflict of laws rules thereof.

3. **Counterparts.** This Assignment may be executed in separate counterparts, each of which is deemed to be an original and all of which taken together constitute one and the same agreement.

4. Miscellaneous. This Assignment is subject to all the terms and conditions of the Purchase Agreement. The parties intend that this Assignment is for recordation purposes only and its terms will not modify the applicable terms and conditions of the Purchase Agreement.

5. Further Assurances. Assignor agrees at Assignee's expense to execute such further documents and to perform such further lawful acts as may reasonably be requested by Assignee, to effectuate this Assignment.
