GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors, as such term is defined in the ABL Security Agreement by and among Grantor, Grantee, and the other Grantors (as such term is defined therein) party thereto, dated as of November 15, 2018 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
