CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "**Agreement**"), effective as of May 1, 2019 (the "**Effective Date**"), is by and between American De Rosa Lamparts, LLC, a Limited Liability Company organized and existing under the laws of the state of Delaware with its head office located at 1945 S. Tubeway Avenue, Commerce, California 90040 ("**Assignee**") and Emerson Electric Co., a Corporation organized and existing under the laws of the state of Missouri with its head office located at 8000 West Florissant Avenue, P.O. Box 4100, St. Louis, Missouri 63136 ("**Assignor**").

WITNESSETH:

WHEREAS,

- A. Assignor and Assignee entered into an Asset Purchase Agreement on the Effective Date.
- B. Pursuant to Section 2.1(b) of Asset Purchase Agreement, Assignor sold, assigned, transferred and conveyed to Assignee, and Assignee purchased, acquired and accepted from Assignor all of Assignor's right, title and interest to and in all of the IP Assets set forth on Schedule 1 hereto (the "**Assigned IP**").
- C. Assignor and Assignee now desire to confirm and document passage of all right, title and interest in the Assigned IP from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and as more fully set forth in the Purchase Agreement and subject to the terms and conditions therein, the parties hereto, intending to be legally bound, hereby agree as follows:

1. Unless otherwise defined herein, all capitalized terms used herein shall have the meanings ascribed to such terms in the Purchase Agreement.
2. Assignor hereby confirms its assignment, effective as of the Effective date, and irrevocably sells, conveys, transfers, assigns and delivers to Assignee, and Assignee does hereby acquire and accept, all of Assignor's right, title and interest in, to and under the Assigned IP throughout the universe and all rights corresponding thereto, free and clear of all Encumbrances other than Permitted Encumbrances, together with all goodwill associated therewith and all income, royalties or payments as of the Effective Date or hereafter due or payable in relation to the Assigned IP, and all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world.
3. Assignor and Assignee acknowledge and agree that the representations, warranties, covenants, indemnities, limitations and other terms contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the fullest extent provided therein.

In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

4. Upon the reasonable request by Assignee, Assignor shall, and shall cause its Affiliates to, execute all documents and take all actions as may be necessary to enable Assignee to perfect, enforce, defend, register and/or record its right, title and interest in, to and under the Assigned IP, in each case, without further compensation but at the expense of Assignee.

5. Assignor hereby authorizes and requests the officials of the United States Copyright Office and the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record and register Assignee as assignee and owner of entire right, title and interest in, to and under the Assigned IP.

6. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Delaware without regard to the choice of law principles thereof. This Agreement is binding upon, and inures to the benefit of, the parties hereto and their respective legal representatives, successors and assigns. No waiver, modification or change of any provision of this Agreement shall be valid unless in writing and signed by the party against whom such claimed waiver, modification or change is sought to be enforced.

7. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.




