TRADEMARK TRANSFER STATEMENT

WHEREAS, Naked Biome, Inc., a Delaware corporation (“**Naked Biome**”), is the registered owner of certain trademarks and service marks registered in the United States Patent and Trademark Office, foreign trademark registrations, and common law trademarks and service marks, which are set forth on the Schedule attached hereto (hereinafter collectively referred to as the “**Marks**”) and is the owner of the goodwill associated with the Marks;

WHEREAS, Naked Biome, in that certain Intellectual Property Security Agreement, dated as of April 3, 2018, and recorded with the United States Patent and Trademark Office, previously granted to Venture Lending & Leasing VIII, Inc. (“**Secured Party**”) security interests in all of Naked Biome’s right, title and interest in and to all general intangibles and other intellectual property owned by Naked Biome, including, without limitation, the Marks and associated goodwill as security for certain indebtedness and obligations;

WHEREAS, Naked Biome has defaulted in connection with its secured indebtedness and obligations to Secured Party;

WHEREAS, Secured Party has exercised its post-default rights of foreclosure of its security interests in and to the Marks and the goodwill associated therewith, and pursuant to a power of sale and foreclosure has conveyed on September 11, 2020, the Marks and associated goodwill to Symbiome, Inc., a Delaware corporation (“**Transferee**”); and

WHEREAS, by reason of the exercise of such post-default remedies, all rights of Naked Biome in and to the Marks have been acquired by Transferee.

NOW, THEREFORE, in accordance with Section 9619(b) of the California Uniform Commercial Code, Transferee is entitled to a transfer of record of all right, title and interest of Naked Biome in and to the Marks and associated goodwill, and request is hereby made that the Commissioner of Patents and Trademarks and the United States Patent and Trademark Office accept the foregoing transfer statement and promptly amend its records to reflect the aforesaid transfer to Transferee.
