**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of October 5, 2020 (the "Release"), is made by Cadence Bank, N.A., as Administrative Agent ("Administrative Agent"), in favor of Le Reve Ventures, LLC, a Texas limited liability company ("Grantor").

Administrative Agent hereby acknowledges that this Release may be filed along with any other necessary documentation with the U.S. Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Administrative Agent authorizes Grantor or their designees to record this Release with the U.S. Patent and Trademark Office and any other applicable registry at the sole expense of Grantor.
