**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of October 5, 2020 (the "Release"), is made by Cadence Bank, N.A., as Administrative Agent ("Administrative Agent"), in favor of Lasco Enterprises, LLC, a Texas limited liability company ("Grantor").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, without representation, warranty, or recourse, hereby terminates the Security Agreements, and hereby terminates, cancels, and releases its security interest in and to the Trademark Collateral granted pursuant to the Security Agreements. Administrative Agent hereby acknowledges that this Release may be filed along with any other necessary documentation with the U.S. Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Administrative Agent authorizes Grantor or their designees to record this Release with the U.S. Patent and Trademark Office and any other applicable registry at the sole expense of Grantor.
