**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 8, 2020 ("Release"), is made by First Horizon Bank, formerly known as First Tennessee Bank National Association ("Bank"), in favor of Landair Holdings, Inc., a Tennessee corporation ("Landair Holdings"), Landair Transport, Inc., a Tennessee corporation ("Landair Transport"), Landair Logistics, Inc., a Tennessee corporation ("Landair Logistics"), and Landair Leasing, Inc., a Tennessee corporation ("Landair Leasing" and together with Landair Holdings, Landair Transport, and Landair Logistics, the "Grantors").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of May 30, 2014, and recorded at the United States Patent and Trademark Office ("USPTO") on March 25, 2015 at Reel 5485 Frame 0539 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement"), by and among the Grantors and Bank, the Grantors granted to Bank a continuing security interest in the Grantors' right, title and interest in and to all Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, "Trademark Collateral").

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and the Grantors agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, the Grantors' right, title, and interest in and to all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at the Grantors' expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Tennessee.
