## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, FAIRCHILD PUBLISHING, LLC, a Delaware limited liability company, ROLLING STONE MEDIA, LLC, a Delaware limited liability company, SOURCING JOURNAL MEDIA, LLC, a Delaware limited liability company, SPORTICO, LLC, a Delaware limited liability company, and VARIETY MEDIA, LLC, a Delaware limited liability company (collectively "the Grantors") executed a "Trademark Security Agreement" dated September 25, 2018, which was recorded in the U.S. Trademark Office on September 26, 2018 at Reel/Frame 6445/0183 in in the U.S. Patent Office (hereinafter, the "Grant") in favor of JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, a U.S. national association in its capacity as Administrative Agent (the "Administrative Agent") for the Secured Parties (collectively "the Lenders") as defined in the Credit Agreement dated September 25, 2018 ("the Grant").

WHEREAS, the Grant granted to the Administrative Agent, for the benefit of the Lenders, a security interest in (i) the Grantors' Trademarks, then existing or thereafter acquired or arising and registered and Trademarks licensed under any Licenses, to the extent permitted by such Licenses, to which they are a party, including without limitation, those referred to on Schedule A hereto; (ii) all renewals of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark licensed under any License; and (iv) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark or any Trademark licensed under any License or (b) injury to the goodwill associated with any Trademark or any Trademark licensed under any License.

WHEREAS, Grantors have satisfied all of its Obligations under Trademark Security Agreement, and Administrative Agent's security interest for the benefit of the Lenders is being terminated and cancelled concurrently herewith.

NOW, THEREFORE, in consideration of the foregoing premises, and the satisfaction of all of their Obligations under the Trademark Security Agreement, the Administrative Agent hereby releases without representation or warranty (express or implied) Grantors and all its successors in interest from any and all interest the Administrative Agent for the benefit of the Lenders now has or which it may have with respect to the right, title and interest in and to the subject trademarks (including, without limitation, the trademarks set forth on Exhibit A attached hereto and all other trademarks owned by the Grantors, but for which the Grant may have not been recorded), the goodwill of the business symbolized by said trademarks, and any and all license agreements relating thereto, and all other rights and interests set forth in the Grant.


