Releasee represents and warrants that as of the date of the Second Lien Trademark Security Agreement it did not, and as of the date hereof it does not, own or have any rights in the Released Trademark and the Released Trademark was erroneously included in the list of trademarks in which a security interest was granted to Releasor pursuant to the Second Lien Trademark Security Agreement.
- 3. Release of Security Interest. In reliance of the Releasee's representations and warranties concerning the erroneous grant of a security interest in and to the Released Trademark to Releasor, Releasor, without representation or warranty of any kind, hereby releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Released Trademark. For clarity, the Releasor's security interest in all Trademark Collateral other than the Released Trademark shall remain in full force and effect.
