RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is executed as of October 16, 2020, by PNC BANK, NATIONAL ASSOCIATION (together with its successors and assigns in its capacity as agent and as a lender) ("PNC"), in favor of ROUNDTOWER TECHNOLOGIES, LLC ("Company").


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, PNC hereby releases, assigns, transfers, quitclaims, and conveys to Company all of PNC's right, title and interest held in each of the Collateral (including without limitation all Patents, Trademarks, and Licenses and all goodwill associated therewith) encumbered by the Security Agreement or listed in SCHEDULE A to this Release, and hereby releases, extinguishes, and terminates PNC's lien and security interest therein under the Security Agreement. All obligations and duties under the Security Agreement, to the extent they relate to the Collateral, are hereby released and terminated, and PNC hereby expressly releases and discharges without limitation all claims, demands, and causes of action that it may now have or that might subsequently accrue to it arising out of or connected with, directly or indirectly, the aforesaid Security Agreement, to the extent they relate to the Collateral.

PNC consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively release any such liens or interests in the identified Collateral.

This Release shall be binding upon PNC's legal representatives, assigns, and successors.
