GRANT OF A SECURITY INTEREST -- TRADEMARKS

September 17, 2020

WHEREAS, EMS LINQ, INC., a Delaware corporation, EMS LINQ INTERMEDIATE, LLC, a Delaware limited liability company, EMS ISITE, LLC, a Delaware limited liability company, INFINITE COHESION, LTD., an Ohio limited liability company, SRC SOLUTIONS, INC., a Pennsylvania corporation, COLYAR HOLDINGS LLC, a Delaware limited liability company, COLYAR TECHNOLOGY SOLUTIONS LLC, an Arizona limited liability company, and DYNAMIC INTERNET SOLUTIONS LLC, a Delaware limited liability company (each a "Grantor"), has each adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, each Grantor, among others, has entered into a Pledge and Security Agreement, dated as of September 17, 2020 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of SIXTH STREET SPECIALTY LENDING, INC., as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Grantee"); and

WHEREAS, pursuant to the Security Agreement, each Grantor has granted to the Grantee, and granted to the Grantee for the benefit of the Secured Parties (as such term is defined in the Security Agreement), a continuing security interest in all right, title and interest of such Grantor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor does hereby grant to the Grantee and grant to the Grantee for the benefit of the Secured Parties, a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event that any provision of this Assignment is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.
