**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, pursuant to that certain Pledge and Security Agreement dated August 3, 2015 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement") and evidenced by that certain Notice of Grant of a Security Interest, dated August 3, 2015, recorded in the United States Patent and Trademark Office on August 4, 2015 at Reel 005592, Frame 0581 (the "Trademark Security Notice"), Help at Home, LLC, an Illinois limited liability company ("Releasee"), granted to Cerberus Business Finance, LLC, a Delaware limited liability company ("Releasor"), as collateral agent for itself and certain other Secured Parties, a security interest in all right, title and interest of Releasee in and to the Collateral, including the trademark registrations and applications listed on Schedule A attached hereto (the "Trademarks"); and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Trademark Security Notice.
2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Collateral, including without limitation, its continuing security interest in the Trademarks, and all goodwill of the business connected with the use of, and symbolized by, such Collateral, and hereby terminates the Security Agreement and the Trademark Security Notice.
