**MEMORANDUM AND NOTICE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

PANAVISION INC., a Delaware corporation (“Borrower”), PANAVISION INTERNATIONAL, L.P., a Delaware limited partnership (“PILP”), LIGHT IRON DIGITAL, LLC, a Delaware limited liability company (“Light”), PANAVISION EUROPE LIMITED, a company incorporated in England (“PEL”), and PANALUX LIMITED, a company incorporated in England (“Panalux” and together with Borrower, PILP, Light and PEL each individually, a “Debtor” and collectively, “Debtors”) hereby acknowledge that Debtors have granted to ALTER DOMUS (US) LLC, whose address is 225 W. 




