**GRANT OF SECURITY INTEREST IN TRADEMARKS**

November 6, 2020

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, STERLING METS, L.P., a Delaware limited partnership, acting through its general partner, SMLP New GP, LLC, a Delaware limited liability company (the “Grantor”), with its principal offices at Citi Field, Flushing, New York, 11368, hereby grants to JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, a national banking association with its principal office at 390 Madison Avenue, 27th Floor, New York, New York 10017, as Administrative Agent (the “Grantee”), a continuing security interest in and lien upon the following (except as may be considered Excluded Assets): (i) all of the Grantor’s right, title and interest in, to and under to the trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (the “Marks”), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks.

THIS GRANT OF SECURITY INTEREST IN TRADEMARKS is made to secure the satisfactory performance and payment of the Obligations, as such term is defined in the Guarantee and Collateral Agreement by and among the Grantor, the Grantee and the other parties thereto, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the “Guarantee and Collateral Agreement”). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to them in the Guarantee and Collateral Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Guarantee and Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest in Trademarks are deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall govern.

Notwithstanding anything herein to the contrary, (i) the parties hereto hereby acknowledge and agree that (a) this Grant of Security Interest in Trademarks is subject to the terms of the Credit Agreement

(including Sections 8.2 and 10.20 thereof) and (b) MLB shall be entitled to enforce the provisions of this paragraph directly against any party hereto (or their successors and permitted assigns), (ii) neither the Administrative Agent nor any other Secured Party may foreclose upon any Collateral related to the Franchise unless it is also foreclosing on, or has foreclosed on, the Franchise and (iii) neither the Administrative Agent nor any other Secured Party may sell, transfer or otherwise dispose of any Collateral related to the Franchise to any Person, other than any Person that owns or is acquiring the Franchise.
