RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of October 29, 2020 (this "Release"), is made by Royal Bank of Canada, as administrative agent and collateral agent (in such capacity and together with its successors and assigns, the "Administrative Agent") for the Secured Parties (as defined in the Collateral Agreement referred to below) in favour of Basic Fun, Inc., TBDUM, LLC, and TGS Acquisition LLC (collectively and with all successors thereof, the "Grantor").

WHEREAS, BASIC FUN CANADA HOLDINGS, INC. and BASIC FUN, LTD., as borrowers (the "Borrowers") have entered into a Credit Agreement dated as of August 3, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Borrowers, BASIC FUN HOLDCO, LLC ("Holdings"), the Subsidiaries of Holdings party thereto from time to time, the LENDERS party thereto from time to time, and the Administrative Agent;

WHEREAS, pursuant to the terms of the Credit Agreement, the Grantor and the other grantors party thereto executed and delivered that certain U.S. Guarantee and Collateral Agreement, dated as of August 3, 2017, to the Administrative Agent (as amended, supplemented, restated or otherwise modified from time to time, the "Collateral Agreement") for the benefit of the Secured Parties (capitalized terms used and not defined herein have the meanings given such terms in the Collateral Agreement and the Credit Agreement, as applicable);

WHEREAS, under the terms of the Collateral Agreement, the Grantor granted a security interest in certain property, including, without limitation, certain Intellectual Property of the Grantor, to the Administrative Agent for the benefit of the Secured Parties in that certain Intellectual Property Security Agreement (the "Intellectual Property Security Agreement") dated August 3, 2017, and recorded at the United States Patent and Trademark Office on August 15, 2017 at: Reel 6130 Frame 0569, Reel 6130 Frame 0584, and Reel 6130 Frame 0634 for trademarks; and at Reel 043300 Frame 0587 and Reel 043300 Frame 0679 for patents; and

WHEREAS, Administrative Agent now wishes to release the security interests granted in the Intellectual Property Security Agreement.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent and Grantor agree as follows:

SECTION 1. <u>Defined Terms.</u> Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Collateral Agreement or Intellectual Property Security Agreement.

SECTION 2. <u>Termination and Release</u>. Administrative Agent hereby:

(a) terminates the Intellectual Property Security Agreement;

- (b) terminates, cancels, forever discharges, and releases the security interest in all right, title, and interest in and to the Intellectual Property Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
 - (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with any government office, including but not limited to the Canadian Intellectual Property Office, United States Patent and Trademark Office and the United States Copyright Office, at Grantor's expense.

SECTION 3. Further Assurances. Administrative Agent, upon Grantor's written request and at Grantor's expense, agrees to duly execute, acknowledge, procure and deliver any further reasonable documents and to do such other reasonable acts as may be reasonably requested by Grantor to the extent necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Intellectual Property Collateral, Administrative Agent will, upon Grantor's request and at Grantor's expense, execute and deliver a reasonable release of such Intellectual Property Collateral or other reasonable instrument requested by Grantor that will terminate any such filing with respect to the Intellectual Property Collateral and/or release any interest in the Intellectual Property Collateral conveyed therein.
