**NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST
(INTELLECTUAL PROPERTY)**

This Notice of Successor Agent and Assignment of Security Interest (Intellectual Property), dated as of May 18, 2020 (this "**Notice**"), is entered into among Royal Bank of Canada ("**RBC**"), as Administrative Agent under the Credit Agreement (defined below) and as Collateral Agent under the Collateral Agency and Security Agreement (First Lien) (as defined below) (in such capacities, collectively, the "**Resigning Agent**"), and Wilmington Savings Fund Society, FSB ("**WSFS**"), in its capacity as Successor Administrative Agent and Collateral Agent (collectively, in such capacities, "**Successor Agent**") pursuant to the Credit Agreement (defined below) and Agency Assignment Agreement (defined below). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Credit Agreement, Collateral Agency and Security Agreement, and Agency Assignment Agreement.

W I T N E S S E T H:

WHEREAS, Exela Intermediate Holdings LLC, a Delaware limited liability company and Exela Intermediate LLC, a Delaware limited liability company, and the below listed entities (each a "**Pledgor**"), and the Resigning Agent are party to that certain (i) First Lien Credit Agreement, dated as of July 12, 2017, as amended and restated as of July 13, 2018 and as further amended as of April 16, 2019 (as further amended, restated, supplemented, waived or otherwise modified from time to time prior to the date hereof, the ("**Credit Agreement**"), (ii) Collateral Agency and Security Agreement (First Lien), dated as of July 12, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "**Collateral Agency and Security Agreement**"), and (iii) Agency Assignment Agreement, dated as of May 18, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "**Agency Assignment Agreement**"); and

WHEREAS, pursuant to the Loan Documents, certain Loan Parties granted to the Resigning Agent a security interest in certain collateral;

WHEREAS, the Resigning Agent and applicable Loan Parties entered into the Notice of Grant of Security Interest in Intellectual Property as identified in Schedule A attached hereto (the "**IP Security Agreement**");

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on July 25, 2017 at Reel/Frame Nos. 6112/0892, 6112/0923, 6113/0219, 6113/0117, 6113/0086, 6113/0256, 6113/0393, 6113/0287, 6113/0589, 6113/0318, 6113/0470, 6113/0354, and 6113/0507 for trademarks, and Reel/Frame Nos. 043326/0079 and 043326/0125 for patents, and in the United States Copyright Office on August 1, 2017 at Volume 9950/Document 106; and

WHEREAS, pursuant to the Agency Assignment Agreement dated as of May 18, 2020 entered by and among the Resigning Agent, the Successor Agent, and certain Lenders and Subsidiary Grantors, the Resigning Agent resigned as, and Successor Agent was appointed and accepted appointment as the Administrative Agent and Collateral Agent with all the rights,

powers, privileges and duties of the Resigning Agent as Administrative Agent and Collateral Agent under the applicable Loan Documents, including in and to the IP Security Agreement.

NOW, THEREFORE, the parties agree as follows:

1. Pursuant to the terms and conditions set forth in the Agency and Assignment Agreement, the Resigning Agent ceased to be the Agent under the Loan Documents and is succeeded to and replaced by the Successor Agent as Agent under the Loan Documents, and the Resigning Agent transferred, assigned, granted and conveyed unto the Successor Agent all of its right, title and interest in and to the IP Security Agreement with all attendant liens, rights, title, assignments and interests (including security interests) pertaining to or arising from the Collateral Documents, including in and to the Collateral scheduled on the IP Security Agreement. Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to the Resigning Agent under the Loan Documents, including the IP Security agreement and the Collateral identified on Schedule A attached hereto, which security interest is now succeeded by and transferred to the Successor Agent.

2. All terms set forth in the Agency Assignment Agreement are hereby incorporated herein by reference with the same force and effect as though fully set forth herein. To the extent that the terms set forth herein are inconsistent with the terms of the Agency Assignment Agreement, the terms set forth in the Agency Assignment Agreement shall apply.

3. This Notice may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

4. This Notice and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
