RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), dated as of November 10, 2020, is made by U.S. Bank National Association, a national banking association, as Agent ("Administrative Agent") for the benefit of the Secured Parties (as defined in the Financing Agreement (as defined in the Agreement defined below)), and is as follows:

WHEREAS, **LYKINS COMPANIES, INC.**, an Ohio corporation ("Debtor"), and Administrative Agent are parties to that certain Trademark Security Agreement, dated as of December 22, 2017, which was recorded with the United States Patent and Trademark Office on December 29, 2017, in its records at Reel 6238, Frame 0848, (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Administrative Agent a security interest in, and lien on, all of the Debtor's right, title and interest in and to all of its Trademark Collateral, including, without limitation, all of Debtor's existing and future (a) Trademarks, including, without limitation, those listed on Schedule A attached hereto and made a part hereof; (b) Licenses; (c) all of the goodwill of Debtor's business, including, but not limited to, all goodwill connected with and symbolized by the Trademarks; and (d) proceeds of any of the foregoing.


WHEREAS, Administrative Agent desires to release its rights and security interests in, and lien on, the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby fully and finally releases and terminates (i) its security interest in, liens on, and all other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.
