CONFIRMATORY GRANT OF SECURITY INTERESTS
IN UNITED STATES TRADEMARKS

THIS CONFIRMATORY GRANT OF SECURITY INTERESTS IN UNITED STATES TRADEMARKS (the “**Confirmatory Grant**”) is made effective as of November 30, 2020 by and from each of the undersigned entities (collectively the “**Grantors**”), to and in favor of Wilmington Trust, National Association, a national banking association organized under the laws of the United States, with an address at 50 South Sixth Street, Suite 1290, Minneapolis, Minnesota 55402, solely in its capacity as collateral trustee under the Collateral Trust Agreement referred to in the Collateral Agreement (defined below) (the “**Collateral Trustee**”), for the benefit of the Indenture Secured Parties (such term, and each other capitalized term used herein, having the meaning assigned in the Collateral Agreement referenced below).

W I T N E S S E T H:

WHEREAS, reference is made to that certain Indenture, dated as of November 30, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “**Indenture**”), among Tenneco Inc., a Delaware corporation (the “**Company**”), the other Subsidiaries of the Company party thereto and Wilmington Trust, National Association, as trustee (the “**Notes Trustee**”);

WHEREAS, Grantors are party to that certain Collateral Agreement dated as of November 30, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “**Collateral Agreement**”), among Grantors and the Collateral Trustee pursuant to which Grantors granted a security interest to the Collateral Trustee in, to and under certain Intellectual Property, including the Trademarks and Trademark Licenses, that are not Excluded Assets, and are required to execute and deliver this Confirmatory Grant; and

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Collateral Agreement.

2) Grant of Security Interests. Each Grantor hereby grants to the Collateral Trustee for the benefit of the Indenture Secured Parties, as security for such Grantor’s Indenture Secured Obligations, a security interest in all right, title and interest of such Grantor in, to and under the Trademarks and Trademark Licenses, including, without limitation, those that are listed on Exhibit A attached hereto, and excluding any Excluded Assets (collectively, the “**Trademark Collateral**”).

3) Acknowledgement. 4) Governing Law.
