**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WITNESSETH:

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 31, 2020 (this "Termination and Release"), is made by HPS INVESTMENT PARTNERS, LLC, as administrative agent and collateral agent for the Secured Parties (in such capacity and together with its successors and assigns in such capacity, the "Agent") in favor of each of the parties set forth on Schedule A hereto (collectively, the "Grantors").

WHEREAS, pursuant to that certain Credit Agreement dated as of May 10, 2017 by and among AFFINION GROUP HOLDINGS, INC., a Delaware corporation, AFFINION GROUP, INC., a Delaware corporation, the lenders from time to time party thereto (the "Lenders"), the Agent for the Lenders, and the other parties from time to time party thereto (as the same may hereafter be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders severally agreed to make extensions of credit to the Borrower upon the terms and conditions set forth therein, to the Borrower; and

WHEREAS, as a condition precedent to the obligation of the Lenders to make their respective extension of credit to the Borrower under the Credit Agreement, the Grantors entered into a Collateral Agreement dated as of May 10, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") between each of the Grantors and the Agent, pursuant to which each of the Grantors assigned, transferred and granted to the Agent, for the benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined below);

WHEREAS, in connection with that certain Trademark Security Agreement, between the Agent and Grantors (the "Trademark Security Agreement"), each Grantor, by reference to the Collateral Agreement, reaffirmed its intent to grant the security interest to the Agent specifically in all the trademarks for which applications are registered and pending of such Grantor and all of the goodwill associated therewith, which are set forth on Schedule B (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 12, 2017, at Reel 6082 and Frame 0285, Reel 6082 and Frame 0304, Reel 6082 and Frame 0376, Reel 6082 and Frame 0406, Reel 6082 and Frame 0440, Reel 6082 and Frame 0468, Reel 6082 and Frame 0492, and Reel 6082 and Frame 0528,

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Release of Security Interest. The Agent, without representation or warranty of any kind, hereby terminates, releases and discharges its security interest in the Trademark Collateral and all goodwill associated therewith, and any right, title or interest of the Agent in such Trademark Collateral and all goodwill associated therewith shall hereby cease and become void. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral and any goodwill associated therewith, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

2. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect


the release of the security interest contemplated hereby, in the case of the foregoing, as may be reasonable requested by any Grantor, and at the sole cost and expense of such Grantor.

3. Governing Law. THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAW RULES THAT WOULD RESULT IN THE APPLICATION OF A DIFFERENT GOVERNING LAW (OTHER THAN ANY MANDATORY PROVISIONS OF THE UCC RELATING TO THE LAW GOVERNING PERFECTION AND EFFECT OF PERFECTION OF THE SECURITY INTERESTS).

4 . Counterparts. This Termination and Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
