RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interests in Trademarks (“Release”) is made as of the 18th day of December, 2020 (the “Release Date”), by BANK OF AMERICA, N.A. (“Administrative Agent”) having an office located at One Bryant Park, New York, New York 10036 in favor of SYNAGRO-WWT, INC. (“Synagro-WWT”), SYNAGRO TECHNOLOGIES, INC. (“Synagro Technologies”), and together with Synagro-WWT, the “Grantors”, and each a “Grantor”) having an office located at 435 Williams Ct, Suite 100, Baltimore, Maryland 21220.

WHEREAS, with reference to the Collateral Agreement dated as of November 9, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), pursuant to which each Grantor granted to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, the Grantors and the Administrative Agent entered into that certain Trademark Security Agreement dated November 9, 2018 (the “Trademark Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded on December 4, 2018 with the Assignment Recordation Branch of the U.S. Patent and Trademark Office, at Reel 006494, Frame 0072. All capitalized term used, but not defined herein, shall have the meaning ascribed or referenced to them in the Trademark Security Agreement.

WHEREAS, Administrative Agent has agreed to terminate, release and discharge its Security Interest in all the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor and Administrative Agent hereby agree as follows:

All of Administrative Agent’s Security Interest in the Trademark Collateral, including those registered and applied for Trademarks listed on Schedule A, pursuant to the Trademark Security Agreement are hereby, without representation or warranty of any kind, terminated, released, cancelled and discharged, and the Administrative Agent shall take any other action, including executing and delivering any additional termination documents reasonably requested by each Grantor at such Grantor’s cost and expense, including filings with the U.S. Patent and Trademark Office against the Trademark Collateral, as shall be necessary to effect the purpose of this Release, each at such Grantor’s cost and expense.

If and to the extent that Administrative Agent has acquired any right, title or interest in or to any of the Trademark Collateral, it hereby, without representation or warranty of any kind, re-assigns and re-transfers such rights, title or interest to the applicable Grantor, along with any goodwill in the Trademark Collateral that the Administrative Agent may have acquired.

The Administrative Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.

This Release shall be governed by the laws of the State of New York. This Release shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Release may be executed counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.
