**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of December 18, 2020 (this "Release") is made by Cadence Bank, N.A., as administrative agent and as collateral agent (together with its successors in such capacities, the "Administrative Agent"), under that certain Intellectual Property Security Agreement dated as of October 28, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement") by and between AMRO Fabricating Corporation, a California Corporation (the "AMRO") and the Administrative Agent for the Secured Parties, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 7088, Frame 0845. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the IP Security Agreement.

Pursuant to the IP Security Agreement, AMRO granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest ("Security Interest") in AMRO's right, title and interest of every kind and nature in the IP Collateral listed on Schedule I attached hereto.

The Administrative Agent now wishes to release and terminate all right, title and interest in the IP Collateral under the IP Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent, on behalf of itself and the other Secured Parties, releases and terminates all right, title and interest in, to and under the IP Security Agreement in the IP Collateral.
