SUPPLEMENT NO. 1 TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Supplement"), dated as of December 23, 2020, is made by the Persons listed on the signature page hereof (individually, each a "Grantor" and collectively, jointly and severally, the "Grantors") in favor of PNC Bank, National Association, as a lender and as Agent for the Lenders party from time to time to the Credit Agreement (together with its successors and assigns in such capacity, "Agent") pursuant to that certain Intellectual Property Security Agreement, dated as of February 19, 2020 and as recorded with the United States Patent and Trademark Office (as it may be from time to time be further amended, restated, amended and restated, supplemented, extended, joined or otherwise modified from time to time, the "IP Security Agreement"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the IP Security Agreement.


Each Grantor hereby confirms the grant to the Agent, for the benefit of the Agent and the Lenders, on the same terms as set forth in the IP Security Agreement, of a continuing security interest in and Lien upon all of such Grantor's right, title and interest in and to its respective Collateral, in each case whether now or hereafter existing or in which such Grantor now has or hereafter acquires an interest and wherever the same may be located. Each Grantor hereby agrees that the attached Schedule B shall constitute part of and an addition to Schedule B to the IP Security Agreement and that each other provision of the IP Security Agreement is hereby incorporated *mutatis mutandis*.
