RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”), dated as of December 31, 2020 (the “Effective Date”), is made by Wilmington Savings Fund Society, FSB, as successor Administrative Agent and Collateral Agent (together with its successors and permitted assigns, the “Collateral Agent”), in favor of Covia Holdings Corporation (“Borrower”) and each of the entities identified as grantors on the signature pages hereto (with Borrower, collectively, the “Grantors”). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Pledge Agreement (as defined below), the Trademark Security Agreement (as defined below) and the Resignation Agreement (as defined below).

WHEREAS, the Grantors are party to that certain Pledge and Security Agreement, dated as of June 1, 2018 (the “Pledge Agreement”), by and among each of the Grantors and the other grantor parties thereto and Barclays Bank PLC, as collateral agent (in such capacity, together with its successors and permitted assigns, the “Former Agent”);

WHEREAS, in connection with the Pledge Agreement, the Grantors and the Former Agent entered into that certain Trademark Security Agreement, dated as of June 1, 2018 (the “Trademark Security Agreement”), pursuant to which each of the Grantors granted to the Former Agent (for the benefit of the Secured Parties (as defined in the Pledge Agreement)) a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 27, 2018 at Reel/Frame 6423/0134;

WHEREAS, pursuant to that certain Resignation, Appointment and Acceptance Agreement, dated as of August 20, 2020 (the “Resignation Agreement”), by and among the Former Agent, the Collateral Agent, Borrower and the Required Lenders party thereto, the Former Agent assigned to the Collateral Agent, and the Collateral Agent assumed, all of the Former Agent’s rights and obligations under the Pledge Agreement and the Trademark Security Agreement and the security interest and lien granted thereunder;

WHEREAS, in connection with the Resignation Agreement, the Former Agent and the Collateral Agent entered into that certain Assignment of Security Interest in Trademark Collateral, dated as of August 20, 2020 (the “Assignment Agreement”), to confirm the foregoing assignment and assumption for the purpose of recording it with the United States Patent and Trademark Office;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on October 19, 2020 at Reel/Frame 7077/0588;

WHEREAS, the Pledge Agreement has been terminated and the liens and security interests granted pursuant thereto have been released; and

WHEREAS, the Grantors have requested that the Collateral Agent release, terminate and extinguish, and the Collateral Agent has agreed to release, terminate and extinguish, its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Release of Security Interest. The Collateral Agent hereby unconditionally and expressly releases, terminates and extinguishes in their entirety all liens, assignments and security interests in and to the Trademark Collateral granted to the Collateral Agent under the Pledge Agreement and Trademark Security Agreement, including, without limitation, with respect to the trademarks, trade dress, service marks, certification marks and collective marks identified on Schedule A attached hereto and made a part hereof, and re-assigns to the Grantors, any right, title or interest the Collateral Agent may have in, to or under the Trademark Collateral.

2. Termination of Trademark Security Agreement. The Trademark Security Agreement is hereby terminated, effective immediately, and shall be of no further force or effect.

3. Further Assurances. The Collateral Agent hereby authorizes each Grantor or the applicable Grantor's authorized representative to record this Release with the United States Patent and Trademark Office. The Collateral Agent consents and agrees to execute and deliver, at the request and cost of a Grantor or any successor-in-interest or assignee thereof, such further instruments, documents, and release forms as such Grantor may reasonably request to more effectively release, terminate and extinguish any security interests of the Collateral Agent in the Trademark Collateral. This Release shall be binding upon the Collateral Agent's legal representatives, assigns and successors.

4. Counterparts. This Release may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute a single instrument. Delivery of an executed counterpart of this Release by electronic means shall be equally effective as delivery of a manually executed counterpart hereof.

5. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York and the applicable federal laws of the United States of America, without regard to any conflict of laws principles that would result in the application of the laws of another jurisdiction.
