TRADEMARK COLLATERAL AGREEMENT AND NOTICE

This Trademark Collateral Agreement and Notice dated as of January 4, 2021 ("Trademark Agreement"), is made among BUDDY PLATFORM, INC., a Delaware corporation with its principal address at 300 Lenora Street, #1591, Seattle, WA 98101, USA and LIFI LABS INC., a Delaware corporation with its principal address at 350 Townsend Street, #830, San Francisco, CA 94107, USA (individually and collectively, "Grantor") and Partners for Growth VI, L.P., 1751 Tiburon Blvd., Tiburon, California 94920 ("Secured Party") pursuant to a Loan and Security Agreement, an Intellectual Property Security Agreement of even date herewith by and among Grantor and Secured Party (the "IP Security Agreement") and pursuant to certain other loan documents referenced therein (collectively, the "Loan Documents").

WHEREAS, Grantor is the owner of certain trademarks, including all federal applications and/or registrations therefor, together with the goodwill of the business connected with the use of and symbolized thereby, as listed on Exhibit 1 hereto (the "Marks"); and


WHEREAS, Secured Party has agreed to extend certain credit to Grantor on condition that the Grantor pledge and grant to Secured Party as collateral for the Obligations (as defined in the Loan Documents) a security interest and lien in and to the Marks and all proceeds thereof and all other related claims and rights as more fully described in the IP Security Agreement in favor of the Secured Party, by and among Grantor and Secured Party;

NOW THEREFORE, for good and valuable consideration, as security for the due and timely payment and performance of the Obligations, Grantor hereby pledges and grants to Secured Party a security interest and lien in and to the Marks and all proceeds thereof and gives notice of such security interest and the existence of such Security Agreement providing therefor.


