GRANT OF SECURITY INTEREST
TRADEMARKS

Reference is hereby made to that certain First Lien Pledge and Security Agreement among the Persons listed on the signature pages hereof (collectively, the "Grantors" and each a "Grantor"), the other grantors from time to time party thereto and U.S. Bank National Association, as collateral agent (together with its successors and assigns, the "Notes Collateral Agent"), dated as of January 7, 2021 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement").

For good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor, on this 7th day of January, 2021, assigns and grants to the Notes Collateral Agent for the benefit of the Secured Parties, a security interest in (i) all of each Grantor's right, title and interest in and to the trademarks, trademark registrations, trademark applications and trademark licenses (the "Trademarks") set forth on Schedule A attached hereto and all reissues, extensions or renewals thereof; (ii) all Proceeds (as such term is defined in the Pledge and Security Agreement referred to below) of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same.

Capitalized terms used herein without definition shall have the meanings assigned to such terms in the Pledge and Security Agreement.

THIS GRANT OF SECURITY INTEREST (this "Grant"), is made to secure the satisfactory performance and payment of all the "Secured Obligations" of each Grantor.

This Grant has been executed and delivered by the Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. Each Grantor authorizes and requests that the Commissioner for Trademarks records this Grant.

This Grant has been granted in conjunction with the security interest granted to the Notes Collateral Agent under the Pledge and Security Agreement. The rights and remedies of the Notes Collateral Agent with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Pledge and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall govern.

This Grant may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Grant by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart. The words "execution," "signed," "signature," "delivery," and words of like import in or relating to this Grant hereby shall be deemed to include Electronic Signatures (as defined below), deliveries or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system, as the case may be. "Electronic Signatures" means any electronic symbol or process attached to, or associated

with, any contract or other record and adopted by a person with the intent to sign, authenticate or accept such contract or record.

This Grant shall be governed by, and construed in accordance with, the laws of the State of New York.
