AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY AGREEMENT

This Affidavit to Affirm the Release of Security Agreement is effective as of January 6, 2021 pursuant to the fulfillment of the loan obligations.

I, Gene J. Cellini, do hereby declare as follows:

I am the Senior Vice President - Tax, Secretary and Treasurer of **L. K. Comstock & Company, Inc.**, a New York corporation ("Company").

1. Pursuant to that certain Amended and Restated Security Agreement, dated as of November 13, 2002 (the "Security Agreement"), Company granted a security interest to Bank of America, N. A. (the "Administrative Agent") in the trademark registrations set forth on Schedule A attached hereto (the "Trademarks").
2. The Security Agreement was recorded at the U.S. Patent and Trademark Office (the "PTO") on December 11, 2002 at Reel/Frame 2633/0831 with respect to the Trademarks.
3. To the best of my knowledge, the obligations secured under the Security Agreement were satisfied. Company repaid all its outstanding loans and other obligations in full, and the Administrative Agent, on behalf of itself and the holders of the Secured Obligations, terminated and released its security interest in the Trademarks.
4. Due to unknown reasons, a release of the Security Agreement was not filed with the USPTO.
