1. terminates and releases any and all liens and security interests and reassigns to the Grantor any and all right, title and interest of the Grantee pursuant to the Security Agreement and the Trademark Security Agreement in and to the Trademarks, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
