**FOURTH AMENDMENT TO  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS FOURTH AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT** (the “Amendment”) is made as of the 31<sup>st</sup> day of December 2020 by and between **INMUSIC BRANDS, INC.**, a Florida corporation with a place of business at 200 Scenic View Drive, Suite 201, Cumberland, Rhode Island 02864 (“inMusic Brands”) and **BANK OF AMERICA, N.A.**, a national banking association with an office at 100 Westminster Street, Providence, Rhode Island 02903 (the “Bank”), in consideration of the mutual covenants herein contained and benefits to be derived herefrom.

**RECITALS**

A. inMusic Brands executed and delivered that certain Intellectual Property Security Agreement dated as of September 28, 2012 (as amended and in effect, the “IP Agreement”) in favor of the Bank and recorded with the Trademark Division of the United States Patent and Trademark Office (the “USPTO”) on October 18, 2012 at Reel 4883, Frame 0383, and recorded with the Patent Division of the USPTO on October 22, 2012 at Reel 029164, Frame 0024 pursuant to which inMusic Brands pledged, assigned and granted a security interest in favor of the Bank in the Intellectual Property Collateral (as defined therein); and

B. inMusic Brands has acquired additional Intellectual Property Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Intellectual Property Collateral in favor of the Bank.

Accordingly, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. Amendment to IP Agreement.
  - (a) Exhibit A to the IP Agreement is hereby amended by adding thereto the Intellectual Property Collateral set forth on **Schedule 1** attached hereto and incorporated herein by reference. The Intellectual Property Collateral set forth on **Schedule 1** is in addition and supplemental to the Intellectual Property Collateral listed on Exhibit A of the IP Agreement and does not replace or restate any Intellectual Property Collateral contained therein.
  - (b) Exhibit B to the IP Agreement is hereby amended by adding thereto the Intellectual Property Collateral set forth on **Schedule 2** attached hereto and incorporated herein by reference. The Intellectual Property Collateral set forth on **Schedule 2** is in addition and supplemental to the Intellectual Property Collateral listed on Exhibit B of the IP Agreement and does not replace or restate any Intellectual Property Collateral contained therein.
  - (c) Exhibit C to the IP Agreement is hereby amended by adding thereto the Intellectual Property Collateral set forth on **Schedule 3** attached hereto and incorporated herein by reference. The Intellectual Property Collateral set forth on **Schedule 3** is in addition and supplemental to the Intellectual Property Collateral

listed on Exhibit C of the IP Agreement and does not replace or restate any Intellectual Property Collateral contained therein.


3. Miscellaneous:

- (a) inMusic Brands authorizes and requests that the United States Copyright Office record this Amendment or evidence of same.
- (b) inMusic Brands authorizes and requests that the Commissioner of Patents and Trademarks record this Amendment or evidence of same.
- (c) Except as expressly modified herein, all terms and conditions of the IP Agreement remain in full force and effect. inMusic Brands hereby ratifies, confirms and reaffirms the grant of a security interest and all of the representations, warranties and covenants contained in the IP Agreement.
- (d) This Amendment covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
- (e) This Amendment may be executed in multiple identical counterparts (including by facsimile or e-mail transmission of an Adobe portable document file format (also known as a PDF file)), each of which when duly executed will be deemed an original, and all of which will be construed together as one agreement.
