Pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), the undersigned certifies as follows:

**FIRST:** The name, state of domicile, jurisdiction of formation or organization and type of entity of each of the constituent limited liability companies are as follows: (i) FIS iWorks LLC, a Delaware limited liability company, and (ii) FIS Capital Markets US LLC, a Delaware limited liability company.

**SECOND:** An Agreement and Plan of Merger (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by each of the constituent limited liability companies in accordance with the requirements of Section 18-209 of the DLLCA.
