ASSIGNMENT AND ASSUMPTION OF GRANT OF TRADEMARK SECURITY INTEREST

February 11, 2021

This ASSIGNMENT AND ASSUMPTION OF GRANT OF TRADEMARK SECURITY INTEREST dated as of February 11, 2021, (this "Assignment and Assumption") is made by **GORDON BROTHERS FINANCE COMPANY**, a Delaware corporation, with an address of 800 Boylston Street, 27th Floor, Boston, Massachusetts 02199 (USA) as agent (in such capacity, the "Assignor") and **CALLODINE COMMERCIAL FINANCE, LLC**, a Delaware limited liability corporation, with an address of Two International Place, Suite 1830, Boston, Massachusetts 02110(USA) as successor agent (in such capacity, the "Assignee").

WHEREAS pursuant to the Grant of Security Interest in Trademarks, dated as July 26, 2019, by and between **SBARRO FRANCHISE CO. LLC**, a Delaware limited liability company, with its principal address at 1328 Dublin Road, Columbus, Ohio 43215 (USA) ("Franchise Co.") and **SBARRO LLC**, a New York limited liability company, with its principal address at 1328 Dublin Road, Columbus, Ohio 43215 (USA) ("Sbarro", and together with Franchise Co., each an "Existing Grantor" and collectively, the "Existing Grantors"), and the Assignor, as agent (as heretofore, amended, modified and supplemented, the "Existing Grant of Security Interest in Trademarks"), the Existing Grantors granted to the Assignor the security interest in, among other collateral, the Existing Trademarks (as defined below);

WHEREAS, pursuant to the Grant of Security Interest in Trademarks, dated July 26, 2019, and recorded on (1) July 26, 2019 with the United States Patent and Trademark Office at Reel 6704, Frame 0466, and (2) January 11, 2021 with the United States Patent and Trademark Office at Reel 7183, Frame 0695, the Existing Grantors granted to the Assignor a continuing security interest in all of the Existing Grantors' Trademark Collateral (as defined in the Existing Grant of Security Interest in Trademarks), including those set forth on Schedule A attached hereto (the "Existing Trademarks");

WHEREAS, among others, the Assignor and the Assignee have entered into that certain Agency Transfer Agreement, dated as January 4, 2021 (the "Transfer Agreement"), whereby the Assignor transferred to the Assignee, among other things, all of the Assignor's rights and obligations under the Existing Grant of Security Interest in Trademarks; and

WHEREAS, the Assignor wishes to confirm its transfer of all of its rights and obligations under the Existing Grant of Security Interest in Trademarks to the Assignee, and the Assignee wishes to obtain from the Assignor, all of the Assignor's rights and obligations under the Existing Grant of Security Interest in Trademarks, including the secured rights in the Existing Trademarks;

NOW THEREFORE; FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns, transfers and sets over to the Assignee without recourse and without any representation or warranty of any kind, nature or description, other than those contained in the Transfer Agreement, and the Assignee hereby assumes from the Assignor, the Assignor's entire right, title and interest in and to the Existing Grant of Security Interest in Trademarks and to the secured rights in and to the Existing Trademarks.

This assignment is made in accordance with and subject to the Transfer Agreement. In the event of any inconsistency between the terms and conditions of the Transfer Agreement and this assignment, the terms of the Transfer Agreement shall control.
