RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) dated as of December 30, 2020, is made by GOLDMAN SACHS BANK USA, as Collateral Agent for the Secured Parties (the “**Collateral Agent**”) in favor of SUPERIOR VISION SERVICES, INC., a Delaware corporation, SUPERIOR VISION BENEFIT MANAGEMENT, INC., a New Jersey corporation and DAVIS VISION, INC., a New York corporation (each a “**Grantor**”, and collectively, the “**Grantors**”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the First Lien Trademark Security Agreement (as defined below).

WHEREAS, the Grantors, certain other grantors and the Collateral Agent are party to that certain First Lien Collateral Agreement, dated as of December 1, 2017 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**First Lien Security Agreement**”) pursuant to which the Grantors executed and delivered that certain First Lien Trademark Security Agreement, dated as of December 1, 2017, in favor of the Collateral Agent (the “**First Lien Trademark Security Agreement**”);

WHEREAS, pursuant to the First Lien Security Agreement and the First Lien Trademark Security Agreement, each Grantor granted to the Collateral Agent a security interest in all of such Grantor's right, title and interest in, to and under the United States Trademark registrations and Trademark applications listed on Schedule I attached hereto, but excluding any intent-to-use Trademark application prior to the filing of a “Statement of Use” or “Amendment to Allege to Use” with respect thereto (the “**Trademark Collateral**”);

WHEREAS, the First Lien Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 5, 2017 at Reel/Frame 6221/0127 (for Davis Vision, Inc.), Reel/Frame 6294/0143 (for Superior Vision Benefit Management, Inc.) and Reel/Frame 6221/0181 (for Superior Vision Services, Inc.);


WHEREAS each Grantor has requested that the Collateral Agent now terminate and release its security interest in the Trademark Collateral;

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby terminates the First Lien Trademark Security Agreement, hereby terminates, cancels and releases its security interest in the Trademark Collateral without recourse to the Collateral Agent, and without representation or warranty of any kind.


