**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of February 24, 2021 (“Release”), is made by Chatham Capital Management IV, LLC, a Georgia limited liability company, as Collateral Agent (“Collateral Agent”) in favor of Tantum Companies, LLC, a Delaware limited liability company (“Grantor”).

**WHEREAS**, pursuant to that certain Pledge and Security Agreement dated as of July 7, 2017 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”) by and among the Grantor, Collateral Agent, and others party thereto, and the Assignment for Security – Trademarks, Patents and Copyrights dated as of July 7, 2017 by and among the Grantor and Collateral Agent (“IP Security Agreement”), Grantor granted, pledged and collateral assigned to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of Grantor in, to, and under all Collateral (as defined in the IP Security Agreement); and

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on July 7, 2017 at Reel 6105 Frame 0766.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in all right, title and interest of Grantor in, to, and under all Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
